

**Gainesboro Elementary School
Parent Involvement Policy
2017 - 2018**

Gainesboro Elementary School jointly developed this parental involvement policy in consultation with school personnel, community members, and parents and adopted it on September 28, 2017. This policy was distributed to parents of participating children and to the extent practicable, provided in a language the parents can understand. This parent involvement plan will be updated annually to meet the changing needs of parents and the school.

Gainesboro Elementary School will:

Gainesboro Elementary School will:

1. Involve parents in the planning, review, and improvement of the school's parental involvement policy, in an organized, ongoing, and timely way.

Hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements, and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a convenient time to parents, and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite to this meeting all parents of children and will encourage them to attend.

Part 3. BUILDING CAPACITY FOR INVOLVEMENT
